BUSINESS VISA DOCUMENT CHECKLIST

You must hand in the **VISA APPLICATION FORM** (Schengen.pdf) signed and the **RECEIPT** from the online portal (udi.no) when you submit all the necessary documents, otherwise, the application may be rejected.

- All documents must be translated into English or Norwegian
- A4 format copy of each of the documents and with no staples and pins.

Attach the Document Checklist to your application and **deliver the application in following order:**

1	Signed visa application form (Schengen.pdf) and the receipt from the UDI Portal (www.udi.no/en)		
2	Original current passport. Passport must be valid at least 3 months beyond intended travel, issued within the previous 10 years, and containing at least two blank pages. And copy of biodata page from passport.		
3	One passport photo of the applicant with white background (not older than six months). Do not staple or glue the picture to the application form		
4	Copy of valid residence permit in United Arab Emirate (UAE)		
5	Proof of financial means: Bank statements for the past three months signed and stamped by the bank or any verifiable evidence of sufficient means of subsistence during the intended stay, e.g. salary slips for the past three months. Other financial commitments, such as ownership of property and savings		
6	Official invitation letter from the Norwegian company or organization with their contact details, stating the applicant's identity, the length and purpose of the visit (e.g. meetings, conference, operation site visits, sports event, fairs), place of intended stay and who will bear the travel and living costs. The letter should also include information regarding what activities will be performed.		
7	Letter confirming employment or owning a private business stating the applicant's identity, the company's contact details (contact person, e-mail, telephone), including information regarding position of the applicant,		

	<p>purpose and length of the journey, what activities will be performed, place of intended stay and who will bear the travel and living costs.</p> <p>If the applicant is a company owner or self-employed: Certificate of registration of company, business license and similar.</p> <p>Students and researchers should provide proof/certificate of enrolment from home institution.</p>		
8	Valid travel medical insurance for the duration of the stay in Schengen area with a minimum coverage of EURO 30.000.		
9	<p>Flight reservation (round trip, maximum 90 days)</p> <p>The visa will be issued according to the documentation provided and only applicants who fulfill the criteria for a multiple visa will be granted multiple entries.</p> <p>Note: Do not purchase the ticket until visa has been granted</p>		
10	<p>Other supporting documents;</p> <ul style="list-style-type: none"> • copy of family member(s) residence permit in the UAE (If applicable) • Information of length of residence in the UAE (How long you have been residing in the UAE) 		

The Embassy may contact the applicant to request additional information/documentation and to interview the applicant.
