10	Marriage certificate (original) - If you are married to an EU or EEA citizen. The Embassy can request to see a marriage certificate from the EU/EEA member state where the reference is a citizen, or a confirmation that the marriage is recognised by the member state.		
11	Birth Certificate (original) - If one or both of your parents are EU/EEA citizens.		
12	The Birth Certificate of the son/daughter you depend on - If you are a dependent ascendant of an EU/EEA citizen.		
13	Documentation/evidence that the EU/EEA national provides for the applicant - if you are a dependent ascendant, or dependent descendant over 21 years, of an EU/EEA national. (For example receipts for money transfers to you from your EU/EEA national son/daughter or father/mother that you depend on).		
14	Consent from parents and copy of parents' passports (for minors travelling without or with one of the parents) written in or translated to English.		
15	Travel reservation or other proof of intended transport (not necessary to present a ticket)		
16	Travel medical insurance covering the period of stay with a value of at least 30 000 Euro (not mandatory but highly recommended)		
17	Questionnaire C or B from Embassy/VFS website (depending on who you will visit)

Notes to the Checklist

- Please submit the documents in the order of the checklist. All documents must be A4 with no staples, stickers or torn pages. Documents smaller than A4 must be glued to an A4-page.
- When persons below 18 years apply for a visa, both their parents must sign the Cover letter.
- Marriage and birth certificates must be legalised by the Ministry of Foreign Affairs of the issuing country (unless they come from a EU/EEA member state), and translated into English or Norwegian by an authorised translator. The Embassy will verify all original documents (for example passport, original ID-card, birth certificates etc.). The passport can be collected at the VFS office two working days after the application is submitted. The Embassy will return the other original documents to VFS when the case is processed.
- If the application is granted, the visa will be issued according to your travel reservation/proof of intended transport.
