**IMPORTANT!** All applicants must hand in the **printed and signed COVER LETTER**, the **RECEIPT** and **VISA APPLICATION FORM** from the application portal when submitting the application. The Minors need to be signed by parents or legal guardians.

<b>Attention:</b> All documents must be presented in original, and it may be returned to the applicant if copy is provided. <b>The applicant has to meet in person when delivering the documents.</b> <b>注意:</b> 所有材料必须是原件, 如提供复印件, 原件可能退回。申请人需当面提交申请材料。			
<b>One passport photo:</b> Not older than six months (color, 4x5cm, white background). The photo must not be edited. <b>一张护照照片:</b> 6个月内(彩照, 4x5cm, 白色背景), 不能修图。			
<b>Original invitation letter</b> signed by the sponsor/reference person stating the purpose and duration of the visit, and the relation with the applicant (Not older than 6 months). <b>邀请信原件:</b> 挪威邀请人或邀请方亲笔签名的邀请信, 需注明访问目的、停留时间以及与申请人的关系(邀请信需在6个月内出具)。			
<b>Copy of the sponsor/reference's passport</b> , bio data page copy. If the reference person is not a Norwegian citizen, also copy of the reference's residence permit. <b>邀请人护照复印件:</b> 个人信息页复印件。如果邀请人不是挪威公民, 还需提供在挪合法居住许可的复印件。			
<b>Proof of relationship with sponsor/reference person.</b> <ul style="list-style-type: none"> <li><b>For family visit:</b> Notary certificate of family relationship (i.e. marriage certificate, birth certificate whichever is applicable), legalized by the Ministry of Foreign Affairs in Beijing. Original + 1 copy.</li> <li><b>For friend visit:</b> the relationship can be substantiated by original documents, original pictures, letter of invitation etc.</li> </ul> <b>与邀请人或邀请方关系证明:</b> <ul style="list-style-type: none"> <li><b>探亲签证:</b> 亲属关系公证书(例如结婚证, 出生证明等), 需由北京外交部认证。原件+1份复印件</li> <li><b>访友签证:</b> 提供能证明申请人和邀请人朋友关系的文件原件、照片原件、邀请信等</li> </ul>			
<b>Letter of employment/studies</b> on company or school official paper, signed and stamped. Mentioning: <ul style="list-style-type: none"> <li>Full address and contacts of the company or school</li> <li>Permission of absence, name and function of the person giving permission</li> <li><b>Employed:</b> Name and position of the applicant, years of employment, and salary</li> <li><b>Students:</b> Description of studies</li> </ul> As well as <ul style="list-style-type: none"> <li><b>Employed:</b> a sealed copy of the company business license or organization code</li> <li><b>Students:</b> a copy of student card</li> </ul> <b>For Minors:</b> <ul style="list-style-type: none"> <li><b>Notary certificate</b> of family relationship or proof of guardianship (i.e. birth certificate), legalized by Ministry of Foreign Affairs in Beijing. Original + 1 copy.</li> <li><b>Letter of employment</b> from parent(s) or legal guardians</li> <li>If the minor is traveling alone or with only one parent, <b>notary certificate of permission to travel</b> from both parents or legal guardians, legalized by the Ministry of Foreign Affairs in Beijing. Original + 1 copy.</li> <li>When parent/parents/guardians is/are not in China, attested by the relevant authorities in the parents'/legal guardians' country of residence.</li> </ul> The original letter and documents must be translated into <b>English</b> .  <b>在职证明或者在读证明:</b> 使用公司或学校正式的信头纸并加盖公章且签字。包括: <ul style="list-style-type: none"> <li>完整的公司地址和联系方式</li> <li>准假证明以及准假人姓名和职位</li> <li><b>在职人员:</b> 申请人姓名、职位、工作年限以及工资</li> </ul>

<p><b>Proof of solvency: Bank statement</b> from the last 3 months.</p> <ul style="list-style-type: none"> <li>• Retired persons: <b>Retirement certificate or proof of pension</b> or other proof of regular income.</li> <li>• Unemployed and married: <b>letter of employment and income of the spouse and notary certificate of marriage</b>, legalized by the Ministry of Foreign Affairs in Beijing. Original+1 copy</li> <li>• Unemployed and not married: Documents showing other source of income</li> <li>• For Minors travelling alone: <b>Bank statement</b> and signed <b>payment statement</b> (in English) from parent(s) or legal guardians (no notarization).</li> </ul> <p><b>偿付能力证明:</b> 最近 3 个月的<b>银行对账单</b>。</p> <ul style="list-style-type: none"> <li>• 退休人员: 退休证明或养老金证明或其他固定收入证明</li> <li>• 无业且已婚人员: 配偶的在职证明和收入证明, 北京外交部认证的结婚证公证书, 原件和 1 份复印件</li> <li>• 无业且未婚人员: 提供其他收入证明</li> <li>• 单独旅行的未成年人: 提供父(母)或法定监护人的银行对账单及签字的<b>同意支付费用声明</b> (英语, 无需公证)</li> </ul> <p><b>Or,</b> <b>Proof of sponsorship and/or of private accommodation form</b> filled out and signed by the sponsor in Norway. People who have at least NOK 500 per day to support themselves during their stay in Norway, and are able to document that they satisfy this requirement, do not need to submit Proof of sponsorship. <b>或者,</b> <b>出具由挪威担保人完整填写且签字的出行费用和/或个人住宿担保表格</b> (可接受复印件)。 如申请人可提供材料证明满足本人每天 500 挪威克朗的费用要求, 则不需要提供此担保表格。</p>		
<p><b>Passports:</b> new and old. New passport valid at least 3 months after expiry of visa, containing minimum two blank pages and issued within the previous ten years. <b>Copy</b> of bio data page in the passports (old and new).</p> <p><b>护照:</b> 新旧护照, 新护照要求在签证有效期后仍有不少于 3 个月有效期, 包含至少 2 页空白页, 且近 10 年内颁发的。<b>护照复印件:</b> 新旧护照的个人信息页复印件。</p>		
<p><b>Hukou:</b> Copy of all used pages (no translation). Only for Chinese nationals. For other nationals: Copy of valid Chinese residence permit.</p> <p><b>户口簿:</b> 所有信息页复印件 (无需翻译), 仅针对中国公民。 外国公民需提供有效的在华居住许可证复印件。</p>		
<p><b>Travel medical insurance</b> for the duration of the stay in the Schengen area with a minimum coverage of EURO 30.000.</p> <p><b>旅行医疗保险:</b> 保险需涵盖在申根地区全部停留时间, 保险金额至少为 30.000 欧。</p>		
<p><b>Power of Attorney</b> -Optional for applicants who want others to represent/assist them in the case. <b>委托授权书</b> (可选, 如果申请人想授权他人协助或查询申请)</p>		

The applicant has been informed that the failure of submitting any of the required documents can lead to the application being refused and has been asked to submit a written explanation if that is the case.
