

Checklist for ADS group Tourist Visa

ADS 团队旅游签证申请审核表

IMPORTANT! ADS visas are issued to members of tourist groups of at least 5 persons. The maximum duration of the stay is 30 days. All applicants must hand in the **printed and signed COVER LETTER**, the **RECEIPT** and **VISA APPLICATION FORM** from the application portal when submitting the application. The Minors need to be signed by parents or legal guardians.

<p>Proof of accommodation: Detailed Hotel reservations for the whole intended stay in the Schengen area.</p> <p>住宿证明：提供整个申根地区停留期间的酒店预订单详情。</p>		
<p>Travel medical insurance for the duration of the stay in the Schengen area, with a minimum coverage of EURO 30.000.</p> <p>旅行医疗保险：保险需涵盖在申根地区全部停留时间，保险金额至少为 30.000 欧。</p>

<p>One passport photo: Not older than six months (color, 4x5cm, white background). The photo must not be edited.</p> <p>一张护照照片：6 个月内 (彩照, 4x5cm, 白色背景), 不能修图。</p>		
<p>Letter of employment/studies on company or school official paper, signed and stamped. Mentioning:</p> <ul style="list-style-type: none"> • Full address and contacts of the company or school • Permission of absence, name and function of the person giving permission • Employed: Name and position of the applicant, years of employment, and salary • Students: Description of studies <p>As well as</p> <ul style="list-style-type: none"> • Employed: a sealed copy of the company business license or organization code • Students: a copy of student card <p>For Minors:</p> <ul style="list-style-type: none"> • Notary certificate of family relationship or proof of guardianship (i.e. birth certificate), legalized by Ministry of Foreign Affairs in Beijing. Original + 1 copy. • Letter of employment from parent(s) or legal guardians • If the minor is traveling alone or with only one parent, notary certificate of permission to travel from both parents or legal guardians, legalized by the Ministry of Foreign Affairs in Beijing. Original + 1 copy. • When parent/parents/guardians is/are not in China, attested by the relevant authorities in the parents'/legal guardians' country of residence.

<p>Proof of solvency: Bank statement from the last 3 months.</p> <ul style="list-style-type: none"> • Retired persons: Retirement certificate or proof of pension or other proof of regular income. • Unemployed and married: letter of employment and income of the spouse and notary certificate of marriage, legalized by the Ministry of Foreign Affairs in Beijing. Original+1 copy • Unemployed and not married: Documents showing other source of income • For Minors travelling alone: Bank statement and signed payment statement (in English) from parent(s) or legal guardians (no notarization) • If traveling costs covered by children: Bank statement and signed payment statement (in English) from children (no notarization) and notary certificate of family relationship legalized by the Ministry of Foreign Affairs in Beijing. <p>Passports: new and old. New passport valid at least 3 months after expiry of visa, containing minimum two blank pages and issued within the previous ten years. Copy of bio data page in the passports (old and new).</p> <p>护照: 新旧护照, 新护照要求在签证有效期后仍有不少于 3 个月有效期, 包含至少 2 页空白页, 且近 10 年内颁发的。护照复印件: 新旧护照的个人信息页复印件。</p>		
<p>Hukou: Copy of all used pages (no translation). Only for Chinese nationals.</p> <p>户口簿: 所有信息复印件 (无需翻译), 仅针对中国公民。</p>		
<p>Application Form: Filled in and signed (of applicant)</p> <p>填写完整并签字的申请表</p>		
<p>Power of Attorney -Optional for applicants who want others to represent/assist them in the case.</p> <p>委托授权书 (可选, 如果申请人想授权他人协助或查询申请)</p>		

Submitting false documents will lead to expulsion from the whole Schengen area.
