- Retired persons: Retirement certificate or proof of pension or other proof of regular income.
- Unemployed and married: letter of employment and income of the spouse and notary certificate of marriage with Apostille . Original+1 copy
- Unemployed and not married: Documents showing other source of income
- For Minors travelling alone: **Bank statement** and signed **payment statement** (in English) from parent(s) or legal guardians (no notarization)
- If traveling costs covered by children: Bank statement and signed payment statement (in English) from children (no notarization) and notary certificate of family relationship with Apostille. Original+1 copy

Passports: New passport valid at least 3 months after expiry of visa, containing minimum two blank pages and issued within the previous ten years. Copy of bio data page in the new passport.
