Documentation required for minors (under 18).  ☐ Application letter (for template, see norway.no/sanfrancisco).
☐ Original or notarized copy of the minor's <b>birth certificate</b> .
☐ If the minor is a dual citizen, the <b>US Passport</b> or a notarized copy of it (if they have one).
☐ Original or notarized copies of <b>both parents' passports</b> (if they do not have passports, a valid ID
is required, still bring any expired passports).
☐ Original or notarized copy(-ies) of the <b>US permanent resident card, US visa or American</b>
<b>passport</b> of the Norwegian parent(s). If the parent(s) did not become an American citizen by birth,
they need to bring their <b>Certificate of Naturalization</b> . If applicable, also bring proof of <b>Retention</b>
of Citizenship for the Norwegian parent(s).
☐ It is required that married couples register their marriage with the Norwegian Tax Administration
in Norway themselves <b>prior</b> to applying for a personal number for their child.
Please send your marriage certificate with an <b>apostille</b> along with copies of your passports to the
Norwegian Tax Administration in Norway (Skatteetaten). Address: Postboks 9200 Grønland, 0134

☐ If the parents were not married at the time of the child's birth, they will have to establish the
paternity or co-maternity in Norway themselves <b><u>prior</u></b> to applying for a personal number for their
child. Please note that NAV requires the birth certificate to have an <b>apostille</b> . Visit NAV's website

paternity or co-maternity:

☐ For dual citizens, the <b>US Passport</b> or a notarized copy of it.
☐ Original or notarized copy of <b>birth certificate.</b>
☐ Original or notarized copy of <b>passport(s)</b> and <b>green card, visa, naturalization certificate,</b> or
retention of citizenship from the parent(s) from which your Norwegian citizenship derives.
