

**Addendum No. 4 to the
Standard Administrative Arrangement
between
the Norwegian Ministry of Foreign Affairs,
the UN Resident Coordinator
and
the United Nations Development Programme**

The Norwegian Ministry of Foreign Affairs, (hereinafter referred to as the "Donor"), the United Nations Resident Coordinator (hereinafter referred to as the "Resident Coordinator") and the United Nations Development Programme (UNDP)'s Multi Partner Trust Fund (MPTF) Office, (hereinafter referred to as "Administrative Agent") acting as the Administrative Agent of the Tanzania One UN Fund (hereinafter referred to as the "Fund") on behalf of itself and all the Participating UN Organizations have agreed as follows:

Whereas in Section 1 of the Standard Administrative Arrangement (SAA) concluded between the Donor, the Resident Coordinator and the Administrative Agent (hereinafter referred to collectively as the "Participants") on 17th October 2016, the Donor committed itself to make a contribution of up to Forty-Five Million Norwegian kroner (NOK 45,000,000) and such further amounts it may decide to support the Fund.

Whereas, in the Addendum 1 to the Standard Administrative Arrangement, signed on the 6th December 2017, the Donor agreed to make an additional contribution of up to Forty-Two million Five Hundred thousand Norwegian kroner (NOK 42,500,000) soft earmarked to UNDAF II Outcome: Violence Against Women and Children (NOK 22,500,000) and Agriculture Outcome under the Kigoma Joint Programme (NOK 20,000,000).

Whereas, in the Addendum 2 to the Standard Administrative Arrangement, signed on the 6th December 2018, the Donor agreed to grant an additional contribution of Sixty Million Norwegian kroner (NOK 60,000,000) earmarked to UNDAF II Outcome 1.1: Economic Growth and Employment (NOK 25,000,000), UNDAF II Outcome 2.4: WASH (NOK 15,000,000) and UNDAF II Outcome 3.3: Violence Against Women and Children (NOK 20,000,000).

Whereas, in the Addendum 3 to the Standard Administrative Arrangement, signed on the 15th April 2019, the Donor revised the schedule of payments in the SAA signed on 17th October 2016 and earmarked to UNDAF II Outcome 1.1: Economic Growth and Employment (NOK 30,000,000), UNDAF II Outcome 3.3: Violence Against Women and Children (NOK 12,800,000), UNDAF II Outcome 5.1: Operating as One (NOK 1,200,000) and UNDAF II Outcome 5.2: Communicating as One (NOK 1,000,000).

The Donor has now agreed to make an additional contribution to the Fund.

The Standard Administrative Arrangement between the Participants is therefore modified as follows:

Section 1: The Donor has agreed to make an additional contribution of up to Ninety Million Norwegian Kroner (NOK 90,000,000) and such further amounts it may decide to support the Fund. The additional funds will be earmarked and distributed as follows:

- A. Funds soft earmarked to the following UNDAF II Outcomes:
- UNDAF II Outcome 3.3: Violence Against Women and Children (NOK 30,000,000);
 - UNDAF II Outcome 2.3: Nutrition (NOK 20,000,000).
- B. Funds focus earmarked to the following emerging needs under the Kigoma Joint Programme:
- Youth and Women's Economic Empowerment (NOK 4,100,000) under the UNDAF II Outcome: 1.1 Economic Growth and Employment;
 - Water, Sanitation and Hygiene (NOK 12,000,000) under the UNDAF II Outcome 2.4: WASH;
 - Agriculture (NOK 16,000,000) under the UNDAF II Outcome 1.1: Economic Growth and Employment;
 - Violence Against Women and Children (NOK 7,000,000) under the UNDAF II Outcome 3.3: Violence Against Women and Children
 - Joint Programme Coordination (NOK 900,000) under the non-programmatic UNDAF II Outcome: Operating as One.

This additional contribution brings the Donor's total contribution to the Fund to **Two Hundred and Forty-Seven Million Five Hundred Thousand Norwegian Kroner (NOK 247,500,000)**, with NOK 90,100,000 earmarked to UNDAF II Outcome 1.1: Economic Growth and Employment, NOK 20,000,000 earmarked to UNDAF Outcome 2.3: Nutrition, NOK 27,000,000 earmarked to UNDAF Outcome 2.4: WASH, NOK 97,300,000 earmarked to UNDAF Outcome 3.3: Violence Against Women and Children, and NOK 3,100,000 earmarked to UNDAF Outcome 5: Non Programmatic.

The Donor will deposit the Contribution by wire transfer, upon signing of this Addendum, in convertible currencies of unrestricted use to the following account:




All other terms and conditions of the Standard Administrative Arrangement remain unchanged. This Addendum shall enter into force on the date of signature by the Participants.

IN WITNESS WHEREOF, the undersigned, being duly authorized representatives of the respective Participants, have signed the present Addendum in English in three copies.


