



## FAMILY AND FRIENDS VISA DOCUMENT CHECKLIST

You must submit all the necessary documents with the application, otherwise the application may be rejected. The documents must be provided in:

- All documents must be translated into English or Norwegian
- A4 format copy of each of the documents and with no staples and pins.

Please print out the document, tick off and sign below to confirm which documents you have submitted. Attach the Document Checklist to your application and **deliver the application in following order**:

1.	<b>Original current passport</b> and all previous passports. Passport must be valid at least 3 months beyond intended travel, issued within the previous 10 years, and containing at least two blank pages.	
2.	Applicant's passport size photo ( <i>white background</i> ) not older than six months ( <i>35-40MM</i> ).	
3.	A signed print out of the <b>harmonised application form</b> from the <a href="#">UDI online application portal</a> »	
4.	Valid travel/health insurance for the entire journey in the Schengen Area. More details can be found at <a href="#">UDI's webpages</a> .	
5.	Confirmed booking (travel itinerary) of roundtrip air ticket, with fixed travel dates of maximum 90 days and correct number of entries, see the <a href="#">regulations of entries</a> .  Do not buy the ticket until visa has been granted. <b>Note:</b> The visa will be issued according to the dates on the flight bookings.	
6.	Invitation letter stating the purpose of the visit and the relation between the applicant and the inviting party/reference.	
7.	Copy of the first and last page of the reference passport (last page only for Indian passport holders).	
8.	Documentation of relationship if visiting family.	
9.	Documents of employment, school, studies and permission for leave, and income if any.	
10.	Sponsorship and invitation form if a sponsor (a private person or an inviting company) is covering your expenses to travel and stay in Norway ( <a href="#">Sponsor for visitors - UDI</a> ). Your sponsor can fill out a digital sponsorship and invitation form with their electronic ID <b>or</b> use our <a href="#">paper form</a> .  <i>If you have a minimum of NOK 500 per day/person and can document this through e.g., a statement of account from your bank or a wage specification for the past six months, you do not need to use a sponsorship form. However, you may still use the form if you believe that will help your application</i>	
11.	Copy of bank account for the last 3 months.	
12.	Copies of <b>the biodata page and all used pages</b> in your passport.	

13.	Letter granting Power of Attorney. <i>(Optional for applicants who want another person to represent them in the case. <a href="#">Separate form for Power of Attorney can be found here.</a>)</i>

**Necessary documents for persons under 18:**

- If you are travelling alone: An original and a copy of letter of consent signed by **both parents** and legalized.
- If you are travelling with only one of your parents: An original and a copy of letter of consent from the **other parent** and legalized.
- If the parent you are travelling with has single custody: A shown original and a **copy of certificate of single custody**.

**The Embassy may contact the applicant to request additional documents.**
