Introduction

The Norwegian Film Collection 2025–2026 is a collection of Blu-rays with 29 recently released Norwegian feature films, documentaries and short films for Norwegian missions/ embassies/consulates/representatives to lend out to EU film festivals and other local, non-commercial film events. The films in the collection are subtitled in eleven languages and are suited for public film screenings.

The Norwegian Film Collection 2025–2026 is a follow-up edition of the earlier editions 2021–2022, 2019–2020, 2017–2018, 2015–2016 and 2012–2013. The Film Collection is an important tool in the effort to build international recognition for Norwegian films and will, in the long run, lead to greater demand and enhanced opportunities for sales and international distribution.

Use of the collection

The Film Collection is produced by the NFI, supported by the Ministry of Foreign Affairs and should be handled locally by Norwegian missions. The missions' task is to evaluate and disseminate films in suitable viewing arenas, particularly in areas with no major international film festivals. This can be done within the framework of a cultural film event or as individual screenings. See Guidelines below for further outlines of use.

11 languages

The collection consists of newer Norwegian feature films, documentaries and short films, all subtitled in eleven languages: Arabic, Chinese, English, French, German, Italian, Norwegian (bokmål), Portuguese (Brazil), Russian, Spanish (Latin American Spanish) and Turkish. The Norwegian Film Institute (NFI) provides English subtitle files in .srt format to enable local translations to further languages. These files can be downloaded among the promotional material for each film.

Promotional material

This user guide contains links to download promotional material for each film. This includes stills, poster, press kit and trailer, depending on availability. The missions are required to use the provided and approved material only, for all promotion and press. Password for the download links is included with the physical collection. Please note that descriptions of sensitive content in the user guide are for internal embassy use only and should not be published or used in any promotion.

Screening version

The main screening version for the Norwegian Film Collection is Blu-ray, which has high resolution and great picture and sound quality. Exceptionally, films can be made available as files. Use of a high resolution H264 file must be agreed upon separately for each title. This service is provided by a commercial third party through NFI, and the costs for this service will have to be covered by the missions.

Guidelines for the use of the Film Collection

The Film Collection contains Norwegian feature films, documentaries and two collections of shorts, one of which is aimed at children.

- 1. The Film Collection will be sent from Norway, free of charge for the receiver. The missions are responsible for administrating and securing the use of the films according to the guidelines and will instruct local users in the conditions for the use of the films.
- 2. Local transportation of the collections must be covered by the local organizer and the missions according to their agreement. The missions must ensure that the films are returned to them after use.
- 3. The main screening format for the Film Collection is Blu-ray. H264 files can be provided upon request through NFI. Payment for file transfer (NOK 1000) must take place before transfer. The digital files will be sent directly to the organizer of the event and not the missions.
- 4. All films in the collection must be shown in their full screening length and not be edited in any way.
- 5. The films included in the collection have been cleared for use only in non-commercial local cultural and/or film events (film weeks, cultural manifestations, or similar), and for educational or research purposes.
- 6. The films may not be featured in screenings for a paying audience but may be screened as part of a program for which a festival fee ("omnibus card") or similar is charged. In cases of doubt, please contact the Norwegian Film Institute for advice.
- 7. The films may not be screened at major international film festivals. In cases of doubt, please contact the Norwegian Film Institute for advice.
- 8. Missions are required to check if the films to be publicly screened are represented by a local cinema/video distributor. If a distribution agreement exists, the local distributor must be contacted for clarification of screening rights and regarding any fees to the local distributor that might arise from the screening(s). The Norwegian Film Institute provides information about the film's international distribution by direct contact via e-mail or telephone. Missions as well as local users are required to take appropriate steps to ensure that films made available through the Film Collection are not subject to piracy.
- 9. Missions are required to inform local partners that press material, advertising, posters, and other publicity material clearly mentions that films made available through the Film Collection are screened in collaboration with the Norwegian Film Institute. The NFI logo may be downloaded from NFI's website.
- 10. An electronic evaluation form must be filled in by the missions once a year about the use of the Film Collection.

Exceptions

The films in the collection may not be screened at major international film festivals that are important for the film's commercial exploitation.

Such festivals are expected to implement quality and reliability standards that meet industry expectations. Generally, this means events fulfilling these standards:

- Good year-round organizational resources
- · Genuinely international selections of films and competition juries
- Good facilities for servicing foreign press correspondents
- Evidence of support from the local film industry
- High standards for official publications and information management (catalogue, programs, flyers)

Festivals fulfilling most of these standards cannot be a venue for screening films from the Film Collection. In cases of doubt, please contact the Norwegian Film Institute for possible participation in international film festivals.

User manual

Part 1 General suggestions for use

The suggestions on the use of the films are based on experiences as reported from the missions using earlier Film Collections. The films can be screened as part of bigger cultural events in collaboration with local partners or related to a singular event organized by the mission.

Many of the films can work well as illustrations of a topic or as starting points for discussions at conferences, seminars, debates etc. Each film page in the User Guide contains suggestions for use, to spark ideas on how the missions can present the films in different contexts. We encourage missions to find relevant angles and approaches to the films, to reach new audiences through local collaborations.

Relevant collaborators can be governmental institutions, institutes like Goethe Institute, youth clubs, film clubs, local cinemas and libraries, cultural houses, other embassies, EU film festivals, Nordic days or similar.

Other Norwegian official institutions promoting Norwegian culture abroad can also be possible collaborators: Music Norway, NORLA, Performing Arts Hub Norway, Design- and Architecture Norway, Norwegian Crafts, and Office for Contemporary Art Norway.

The films can also be lent to educational institutions teaching Norwegian or Nordic languages. For this purpose, the films are subtitled in Norwegian.

The films may also be used for internal screenings for the missions' local employees and associates.

We encourage screening short films ahead of feature films. Some shorts might fit thematically to the feature films and documentaries. Other short films are short enough in duration to replace trailers and advertisements screened ahead of the main program.

Part 2 Film information

On the following pages you will find all films in the Film Collection with synopsis, credits, cast, production company, genre, runtime and year of production.

In addition, we describe suitability and themes, and mention content that might challenge a country's cultural norms. The latter is requested by missions in countries with a strict attitude to freedom of speech in the arts. However, we strongly recommend that missions and organizers watch the films before any screenings are arranged, to make sure the films suit their local audience. Please note that descriptions of sensitive content in the user guide are for internal embassy use only and should not be published or used in any promotion.

RATING 9 ADVICE The film contains some dramatic scenes and covers topics which can be unsettling for children. SUITABLE FOR Youth and adults. CONTENT THAT CAN BE CHALLENGING The film is set in a refugee camp for minors, and the mood of the film is mostly light and humorous, but tackles intense emotions such as grief, isolation and desperation. VIOLENCE One scene depicting playful physical violence. References to gender-based violence and suicide bombing. SEX AND NUDITY Some scenes describe romantic feelings. Short instance of partial nudity in a non-sexual context. ALCOHOL, DRUGS AND SMOKING Scenes depicting waterpipe smoking. References to alcohol. FRIGHTENING AND INTENSE SCENES Some elements of magical realism which can be eerie. One scene shows a deceased person. References to death. PROFANITY Some cursing.

Everybody Hates Johan is an explosive comedy about the life of Johan, a small town loner with a flair for dynamite who finds himself in constant conflict with the rural community. Orphaned at a young age, Johan is brought up by his aunt and uncle and throughout his life, he struggles to find his place in society and cope with his lifelong, unrequited love for the girl next door, whom he nearly blew to pieces during his younger days.

RATING 12 ADVICE This black comedy contains some violence and explosion incidents and is recommended for audiences over 12 years of age. SUITABLE FOR Older youth and adults. CONTENT THAT CAN BE CHALLENGING A black comedy with several instances of violence, explosions and blast accidents. With little gore shown on-screen, the film is focused more on the human drama than the action elements. Parts of the film describe resistance activities during World War II in Norway. The film deals with harassment, conflict and exclusion. A culturally sensitive topic may be the arrival and sudden departure of a Vietnamese woman the main character meets via an agency for international matchmaking. VIOLENCE Many explosion scenes, a few depicting serious and deadly blast accidents. Scenes where children play with dynamite. One scene shows a shotgun being fired at the main character. Several fistfights and conversations about violent acts. SEX AND NUDITY One scene showing kissing between teenage girl and boy. Some talk about sexual acts. One shot is showing topless woman in a non-sexualized context. ALCOHOL, DRUGS AND SMOKING Some cigarette smoking. FRIGHTENING AND INTENSE SCENES A few intense scenes showing explosions and fistfights. PROFANITY Mild cursing.

Ester moves to Alta in Northern Norway in the fall of 1979 and starts her first job as a substitute teacher. To fit in with her colleagues, she keeps her Sámi background hidden. Ester's cousin is a Sámi activist and participates in the demonstrations against the planned hydroelectric power plant in the Alta River. When Ester joins him at the protest camp, her awakening begins. She throws herself into a conflict-filled fight for the preservation of the river and for the right to be herself. *Let the River Flow* is a drama with deep conflicts, about a young person's courage in the fight for Sámi rights in one of the most important events in Sámi and Norwegian history.

RATING 12 **ADVICE** The film contains a brief scene showing a death by suicide. **SUITABLE FOR** Youth and adults. **CONTENT THAT CAN BE CHALLENGING** The film deals with forceful assimilation policies and discrimination of indigenous Sámi people, showing various effects of this mistreatment, such as mental health issues and alcoholism. Civil disobedience and hunger strike are part of the protest tactics used by the activists in the film. **VIOLENCE** Some fistfights, use of force by police towards protesters, and verbal descriptions of violence in the educational system. **ALCOHOL, DRUGS AND SMOKING** Cigarette smoking, alcohol drinking and references to alcoholism. **FRIGHTENING AND INTENSE SCENES** One short, dramatic scene showing a dead body hung by suicide. **PROFANITY** Frequent discriminatory language and verbal harassment of Sámi characters.

Munch is an epic depiction of one of the world's greatest artists of all time. Four defining periods in Edvard Munch's life paint a nuanced picture of a completely distinctive person: What drove him, what inspired him, and what kept his inner flame alive.

RATING 12 ADVICE This film deals with suicide and mental illness. However, there are no close depictions of violence. Parts with a dark atmosphere and strong emotional outbursts. The film is therefore recommended to audiences over 12 years of age. SUITABLE FOR Youth and adults. VIOLENCE One fistfight. SEX AND NUDITY Some partial nudity. A few scenes showing kissing between man and woman. One very short sex-scene between man and woman, but not explicit. ALCOHOL, DRUGS AND SMOKING Alcohol drinking and depictions of alcoholism. Smoking. Some drug use. FRIGHTENING AND INTENSE SCENES Some dark scenes depicting mental illness and a nervous breakdown.

Ninjababy is about 23-year-old Rakel, who discovers her pregnancy six months in after a not-so-romantic one-night stand. Rakel has never wanted to be a mother, and reacts with denial, anger and frustration. She feels that the child in her womb has deceived her: – It's a sneaky ninja baby! *Ninjababy* is a touching and funny film about becoming an adult, and the paradox of how unprepared one can be to experience something as natural as getting pregnant in the middle of one's most fertile age.

MAIN THEMES Equality and gender, Coming-of-age and family **TOPICS** Reproductive rights, identity, relationships. Based on graphic novel *Fallteknikk* by Inga H. Sætre.

RATING 12 ADVICE This film contains scenes with sexualized language and some sexual depictions. It is therefore rated 12+. SUITABLE FOR Older youth and adults. CONTENT THAT CAN BE CHALLENGING The film is about a young woman experiencing an unwanted pregnancy, and contains references to abortion, sexually transmitted diseases, contraception, stillbirths as well a depictions of gynecological exams. The tone is mostly light and humorous, but the film also depicts mental health struggles such as depression. There are references to controversies around transnational adoption. SEX AND NUDITY Two sex scenes. No full nudity, one shot of a female breast. Lots of descriptions and discussions of sex. ALCOHOL, DRUGS AND SMOKING Depictions of alcohol, smoking and drugs. PROFANITY Some cursing and coarse language.

Robert (19), a Polish immigrant working at a fish factory in Norway, has come to earn money to pay off his mother's debts. Robert realizes he has feelings for his colleague Ivar (19). For fear of losing his position within a group of Poles at the factory, he hides his feelings, especially when it turns out that Ivar is doing vogue and is an aspiring drag queen.

CONTENT RATING

RATING 9 **ADVICE** This film contains mild violence and some dramatic scenes with emotional outbursts that may be disturbing to younger children. It is therefore recommended for audiences over 9 years old. **SUITABLE FOR** Youth and adults. **CONTENT THAT CAN BE CHALLENGING** The film tells the love story between two men, and tackles topics such as drag performance, coming out, and dealing with homophobic violence and discrimination. Social dumping and dire work conditions is a topic in the film, as well as stereotypes, racism and prejudice against migration workers from Poland and elsewhere. Taking place in a fish processing facility, many scenes depict the gutting of fish. **VIOLENCE** One short scene depicting and describing violence. Short scene depicting an injured hand after workplace accident. **SEX AND NUDITY** The film contains a few scenes showing sex between men, as well as scenes showing kissing between men and women. The images include nudity from behind, as well as topless men. No full-frontal nudity or explicit depictions of sexual acts or sex organs. **ALCOHOL, DRUGS AND SMOKING** Many scenes showing use of alcohol and smoking. **PROFANITY** Moderate use of strong language and cursing. One instance of a racial slur.

Calm Vega (9), her wild sister Billie (5) and their outdoorsy dad go for an overnight hike in the wilderness. The trip is all fun and games until Daddy falls into a mountain crack and hurts himself badly. Unable to move, he tells the girls to go and find help. Together Vega and Billie set off on a mission across the wild Norwegian nature, and must brave animals, exposure, each other and their own fear. They meet a number of grown-ups, but none of them are able to help.

RATING 6 **ADVICE** The film contains some slightly dramatic scenes. **SUITABLE FOR** Children over the age of 6. **FRIGHTENING AND INTENSE SCENES** Some scenes which can be frightening, such as an accident where the adult protagonist falls into a hole, the children hearing scary animal sounds at night and one dramatic climbing scene. These scenes are short, and the general tone of the film is light and humorous, as problems are solved along the way.

One day, Norwegian explorer superstar Roald Amundsen contacts him and orders an airship to conquer the North Pole. Nobile seizes the opportunity to go down in history. He brings Titina along, and the unlikely trio sets out on an expedition to the last undiscovered place on Earth. Their quest is successful but, in the aftermath, the two men start to quarrel over the glory... Through the eyes of the four-legged celebrity Titina, (re)discover a true story of triumph and defeat.

The Painter and the Thief

Some stories are so incredible that a documentary is required to do them full justice. One such story is the one about the painter and the thief. When two of artist Barbora Kysilkova's most valuable paintings are stolen from a gallery at Frogner in Oslo, the police are able to find the thief after a few days, but the paintings are nowhere to be found. Barbora goes to the trial in hopes of finding clues, but instead she ends up asking the thief if she can paint a portrait of him. This will be the start of a very unusual friendship. Over three years, the cinematic documentary follows the incredible story of the artist looking for her stolen paintings, while at the same time turning the thief into art.

VIOLENCE No depictions of violence. References to violence against women, suicide and overdose. ALCOHOL, DRUGS AND SMOKING Smoking, alcohol drinking. References to and scenes of purchasing illegal drugs. PROFANITY Moderate cursing.

Songs of Earth is a majestic symphony for the big screen. With director Margreth Olin's 85-year-old father as a guide, we experience Norway's most scenic valley, Oldedalen in Nordfjord. This is where he grew up and where generations before him lived in balance with nature. Majestic images of wild mountains, calving glaciers, and bustling wildlife go side by side with the parents' stories about the generations who trod the trails, the relationship we have with nature, and what is valuable in life. The music is composed of unique sound recordings – nature's own melodies, translated and performed by the London Contemporary Orchestra.
