TOURISM/BUSINESS/TRANSIT/VISITS TO FAMILY OR FRIENDS

The following documentation must be submitted with the visa application by <u>all</u> applicants (additional documentation may be required and is listed on the website, but more may be requested by the visa officer). As a general rule you should bring originals of all documents plus a set of certified copies for the consulate to keep. <u>In-house processing time of all cases in the Consulate are 15 days</u>. Please check each bullet and sign below to confirm which documents you have submitted:

Cover letter printed out from the Visa Portal after registration
Your online application form printed out from the Visa Portal after registration
Your receipt for the application fee printed out from the Visa Portal after registration
1 passport photo not older than 6 months. Photo requirements are listed here
A preliminary travel itinerary (booking) showing travel details for the entire trip to Schengen. We recommend that applicants never pay for their travel until a visa has been issued
Passport valid for 3 months beyond the planned date of return from the Schengen Area. Make sure that there is at least two free pages marked "VISAS". Make a copy of the bio-page. The passport must have been issued within the last 10 years, regardless of any extensions
Copies of previous Schengen visas
Proof of Legal Residence in the United States. US Permanent Resident card or US visa valid at least 3 months beyond your stay in the Schengen Area. (B1/B2 VISAS ARE NOT RECOGNIZED). Make a copy of the Resident Card or valid US Visa. If you have a student visa you must also submit your I-20, with a copy. The I-20 must be signed by your student counsellor within the last year
Documents confirming employment , private business , or studies ; including permission to leave for the period of the requested visa. For business/tourist visitors, this must be an original letter with the organisation's letter head completed with a signature from your superior boss.
Documents confirming financial means or income of the applicant in the country of residence
Bank statements for the last three months or \square Statement from employer or \square Last year's tax return
Compulsory travel medical insurance (TMI). According to the Schengen regulations you must include a valid travel insurance policy from a medical insurance company in a) your name and policy holder (if other than applicant); b) stating coverage for at least 30,000 EUR in total (USD 50,000). It must cover for medical emergencies, hospitalization and repatriation expenses. The coverage amount must be spelled out or it must say unlimited; c) it must say zero deductible and have zero co-payment; d) it must spell out validity in the Schengen States and the country/countries of your destination; e) it must be valid for the entire period of your trip; f) policy number must be listed. If a visa is issued, it may include a 15 day grace period; we recommend the travel insurance validity period includes the 15 extra days to take into account weather delays, etc.
