CONSENT TO PASSPORT APPLICATION FOR A MINOR

Parents must give their written consent for passports to be issued to a child under the age of 18.

If there is **joint custody**, both parents must consent to the application. At least one of the parents must accompany the child to the appointment AND <u>produce valid passports</u> for both parents as well as the child. If only one parent is accompanying the child, the other must have signed the consent in advance. If the absent parent is unable to sign the consent form and have their passport present at the appointment, they must go to a Norwegian police station/Norwegian foreign service mission and give written consent and show their valid passport. This must be done <u>prior to</u> the appointment for passport renewal.

In cases of **sole custody**, proof of this (awarded by court order or agreement) must be shown

If the child is in the care of **child welfare services**, written consent from them is required.

In case of persons who are declared **incapable** of managing their affairs, written consent from the appointed guardian is required.
