ADDENDUM NUMBER 1 TO AGREEMENT BETWEEN THE NORWEGIAN MINISTRY OF FOREIGN AFFAIRS AND THE UNITED NATIONS OFFICE ON DRUGS AND CRIME CONCERNING STRENGTHENING CRIMINAL JUSTICE RESPONSE TO FOREST CRIME IN INDONESIA INS-2134 INS-18/0004

1 BACKGROUND

- 1.1 The Norwegian Ministry of Foreign Affairs (MFA) and the Grant Recipient (jointly referred to as the Parties) have entered into an agreement dated 8 August 2018 (the Agreement) concerning INS-2134 INS-18/0004, Strengthening Criminal Justice Response to Forest Crime in Indonesia (the Project).
- 1.2 The Grant Recipient has submitted a request to MFA dated 8 July 2021 regarding a no-cost extension of the Support Period, with which MFA has decided to comply.
- 1.3 The Parties have agreed to amend the Agreement through this addendum number One (the Addendum), which shall be an integrated part of the Agreement.

2 EXTENSION OF THE SUPPORT PERIOD

- 2.1 The Support Period set forth in the Agreement shall hereby be extended to 31 July 2022.

3 REVISED CONDITIONS

- 3.1 The fourth progress report, covering the period from January 2021 to December 2021, shall be submitted to the MFA by 31 January 2022.
- 3.2 The fifth progress and financial report, covering the period from January 2022 to July 2022, shall be included in the project completion report, and shall be submitted in accordance with Article 5, clause 6 of the Agreement.
- 3.3 The correct agreement number for this agreement is INS-2134 INS-18/0004. The signed agreement has agreement number INS-2134-18/004 on the front page.
- 3.4 The total agreement amount was for a maximum of 37 500 000 NOK. 17 600 000 NOK has been disbursed. No further disbursements will be made under the agreement.

4 REMAINING CONDITIONS OF THE AGREEMENT

- 4.1 All other provisions of the Agreement shall remain unchanged and in force.

5 ENTRY INTO FORCE AND DURATION

- 5.1 The Addendum shall enter into force on the date of the last signature, and remain in force until all obligations arising from it have been fulfilled.
