

**Addendum 2**  
to  
**Cost-Sharing Agreement**  
Between the Norwegian Ministry of Foreign Affairs and UNDP  
regarding financial assistance to  
**Support Facility for the Institutional Setup of the Indonesia Peat Restoration**  
Agency  
in  
Indonesia

WHEREAS UNDP and the Norwegian Ministry of Foreign Affairs (MFA) have entered into a Framework Agreement dated 14 December 2015 setting out the general arrangement for receipt and use of resources from Norway,

WHEREAS UNDP and MFA entered into a first Cost Sharing Agreement dated 31 May 2016 with a contribution of NOK 34 million (the Agreement) and a no-cost extension until 31 August 2017 by a first addendum dated 31 May 2017 (Addendum 1), on the same terms and conditions of the Agreement regarding financial assistance to Support Facility for the Institutional Setup of the Indonesia Peat Restoration Agency in Indonesia (the Project),

WHEREAS UNDP in letter dated 11 September 2017 has requested additional financial assistance to the Project, and MFA has decided to comply with the request,

NOW THEREFORE UNDP and MFA have reached the following understanding, which shall constitute Addendum No 2, and an integral part of the Agreement:

1. The Support Period set forth in the Agreement, shall hereby be extended to 31 May 2018 with an additional contribution not exceeding NOK 58,000,000 (Norwegian Kroner fifty eight million)
2. UNDP has submitted a revised workplan and budget prior to the signature of this addendum to MFA.
3. Representatives of MFA, representatives from Indonesia and UNDP shall have consultations by February 2018, as defined in Article IV in the Agreement.
4. In Annex II of the Agreement, the schedule of report submission shall be replaced with the following:

5. Any provision of the Agreement which is not amended by the Addendum or previous addenda shall remain unchanged and in force.
6. The Addendum shall enter into force on the date of its signature, and shall remain in force until both parties have fulfilled all obligations arising from it. The obligations shall be deemed fulfilled when so decided in consultation between the Parties.
