

Amendment No. 01/2018 to MoU between DFID and MFA regarding the South Sumatra Partnership for Landscape Management Support Project INDONESIA

1. I refer to the Memorandum of Understanding (MOU) for the above project signed by **DFID and The Norwegian Ministry of Foreign Affairs** on **16th of November 2015**. Following recent discussions and correspondence DFID propose to change the end date to **31st of March 2020**.
2. I therefore propose that the planned period of November 2015 – March 2018 in paragraph 4 of the original MOU be deleted and replaced by **November 2015 – March 2020**.


