4	Passport valid for at least 3 months after the intended stay in Schengen. The passport shall contain at least		
	two blank pages and have been issued within the previous 10 years. 1 colour copy of passport – main page		
	of current passport.		
	If the passport does not state the place of birth, a copy of ID card or a birth certificate must be submitted.		
5	Travel medical insurance: Proof of travel medical insurance covering the period of intended stay, valid		
	for all Schengen States. Minimum coverage must be 30.000 Euros.		
6	Flight ticket reservation: Copy of flight ticket or flight reservation including return flight. You are advised		
	not to buy the ticket until the visa is granted.		
7	Financial means: Proof of sufficient financial means during intended stay. Bank statements and certificate		
	in English showing movements in the applicant's account for the last three months, signed and stamped		
	by the bank, and/or salary slips, and/or copy of credit card valid throughout the intended stay, or sponsor		
	letter from a person you depend on (and live with), with his/her bank documentation and/or proof of		
	other assets (ex. property).		
	Sponsor for visitors -When you are going to visit Norway, you must document that you have enough		
	money to finance your stay and for the return journey. If you do not have enough money yourself, the		
	person you will be visiting will have to provide a sponsorship form. See <a href="https://www.udi.no">www.udi.no</a> for the sponsorship		
	form		
	Sponsoring as a company or organization-If the person going to visit a company or an organization does		
	not have enough money, the company or business in Norway can pay for their stay. A contact person in		
	the company or business must fill out a sponsorship form. See <a href="https://www.udi.no">www.udi.no</a> for the sponsorship form
