### TOURIST VISA DOCUMENT CHECKLIST

You must hand in the **COVER LETTER** signed and the **RECEIPT** from the application portal when you submit all the necessary documents, otherwise, the application may be rejected.

- All documents must be translated into English or Norwegian
- A4 format copy of each of the documents and with no staples and pins.

Attach the Document Checklist to your application and **deliver the application in following order:**

	Document requirements (A4 format)	Submitted	Not submitted
1	<b>Cover letter and application form.</b> Both must be signed.		
2	<b>Original current passport.</b> Passport must be valid at least 3 months beyond intended travel, issued within the previous 10 years, and containing at least two blank pages. <b>And copy</b> of bio data page.		
3	One passport photo not older than six months. <b><i>Do not staple or glue the pictures to the application form</i></b>		
4	Travel itinerary, detailed information about tourist attractions etc, that the applicant is planning to visit, including dates, transportation and hotels and information about who you are travelling with		
5	Copy of valid residence permit in Qatar Residence permit valid three months beyond the intended date of departure from the territory of the Member States or, for GCC citizens, a Qatar-ID-card, valid for three months		
6	Bank statements for the past three months or any verifiable evidence of sufficient means of subsistence during the intended stay, e.g. salary slips for the past three months. You need to document to have the equivalent of NOK 500 per day/person if you are covering the travel and living expenses yourself		
7	<b>Invitation-</b> If you are visiting someone in Norway, you must have an <u>invitation</u> from the person you are visiting		
8	<b>Sponsor for visitors</b> -When you are going to visit Norway, you must document that you have enough money to finance your stay and for the return journey. If you do not have enough money yourself, the person you will be visiting will have to provide a sponsorship form. See <a href="http://www.udi.no">www.udi.no</a> for the sponsorship form		
9	Travel medical insurance for the duration of the stay in Schengen area with

**Necessary additional documents for children under 18 travelling with one or none of the parents/legal guardian**

- proof of consent by one parent if you are travelling with the other
- copy of the non-travelling parent(s) passport(s)
- if the parent you are travelling with has sole custody: Copy of the Court order establishing family relationship or guardianship for the purpose of the intended detailed trip
- if travelling with none: an affidavit from both parents with details of the planned trip and name of sponsors/guardians during the trip
- proof of enrolment at school

**The Embassy may contact the applicant to request additional information/documentation and to interview the applicant.**
